Terms and Conditions:

All member companies are required to abide by the SALDA Constitution and Medical Device Code of Ethical Marketing and Business Practice.

New members wishing to join SALDA will be required to pay the full annual fee or a pro-rata fee dependent on month when joining. An invoice will be issued to the new member company.

Annual fees are payable on presentation of an annual invoice and will automatically be billed unless a termination notification has been received. SALDA membership will run for a full year from January to December.

Written notice of termination of membership for the following year must be received no later than 30 November of the year prior to cancellation. All subscription fees already paid or due in such notice period must be paid in full and such member will not be entitled to any partial or full refund of subscription fees already paid.

Annual SALDA membership fees are decided by the Executive Committee and ratified by members attending the Annual General Meeting (AGM) of that same year.

Application for membership is subject to approval of the SALDA Executive Committee.

Members are also required to be compliant with the requirements of the South African Health Products Regulatory Authority (SAHPRA).
